I further acknowledge that shooting activities can be very dangerous and involve a substantial risk of serious injury, death, and property damage. I hereby assume full responsibility for such risk, bodily injury, death, or property damage because of negligence of myself or others, while in or upon GCF&G property or while participating in, watching, or otherwise involved in any manner with any associated shooting or club activities. I further agree to indemnify and hold harmless GCF&G, its officers, members, agents, chairmen, and employees, and waive liability for any additional claims, suits, or actions for personal injury, loss of consortium, and property damage for which my heirs, executors, administrators, agents, and each of them, may hereafter acquire against GCF&G, its officers, members, agents, chairmen, and employees to the extent that such claims, suits, or actions derive from injury, damage, or death that occurs in connection with shooting or related activities at GCF&G. By completing this document and participating in the event you are acknowledging that you have read and understand the rules for US Practical Shooting Association, Steel Challenge Shooting Association and the Greene County Fish & Game (GCF&G) Ground Rules and additionally agree to abide by all applicable rules, laws, ordinances and common firearms safety practices while participating in, viewing or attending any GCF&G event.
